# ELIGIBILITY: U.S. Residents only.

The exhibition will include two- and three-dimensional works in all media. All entries must be original and must have been executed since 2009.

There is no limit to the number of entries. Submission is by CD-R only. The submitted pieces of art should be in JPEG format for PC. For 3D work or for certain 2D work where a detail JPEG is essential, 2 JPEG files will be accepted for one entry. The CD-R and the folder in the CD-R must be labeled with the artist's name and the works inside should be labeled accordingly with the Title of the artwork, Size, Media or Medium. Also include a resume in a word document. Electronic entries will be accepted.

# **SIZE**

Two dimensional work must not exceed 72 inches in width and 72 inches in height. Three-dimensional works must not exceed 36 inches by 72 inches by 96 inches or exceed 150 lbs. in weight.

## **ENTRY FEE**

Minimum entry fee is \$45.00 for up to two entries. U.S. Funds only. Additional entries are \$5.00 each. Make check or money-order payable to Phoenix Gallery, or through Paypal on Phoenix Gallery website. All entries are non-refundable.

#### ACCEPTED WORK

All accepted work must be suitably framed and wired for hanging. Sculptors may be required to supply pedestals. Accepted work which differs significantly from the CD may be excluded. No substitutes of accepted work will be allowed. Submitted work must be available for the entire exhibition.

# RECEIVING AND REMOVAL OF WORK

Work may be delivered by hand or by private pre-paid shipment. Shipped work must be sent prepaid. Return shipments must be paid by artist. Return packaging is required. If work is not removed by July 20, there will be a \$60.00 administrative fee and storage charge of \$8.00 per day. After 30 days, the art, including all rights, title and interest of the artist in and to the work will become the property of Phoenix Gallery.

#### **SALES**

A donation of 25% to the Phoenix Gallery is requested. All works must be priced accordingly or marked not for sale.

## LIABILITY AND INSURANCE

Every care will be taken for the safety of all works of art and CDs. Phoenix Gallery, its officers and agents will not be responsible for any loss or damage. Phoenix Gallery does not insure entries and exhibits. Works will be handled and exhibited at the artist's risk.
